**JOURNAL ENTRY OF SATISFACTION OF COSTS REQUIREMENTS OF  
FINAL ORDER**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:


1. On or about February 3, 2004, the Board, upon review of the Initial Order, found Merle. J. Fieser, M.D. (“Licensee”) to be in violation of the Kansas Healing Arts Act, specifically, repeated instances of Licensee’s failure to adhere to the applicable standard of care to such a degree that it constituted ordinary negligence, which constituted professional incompetency as defined pursuant to K.S.A. 65-2837(a)(2). The Board revoked Licensee’s license to practice medicine and surgery in the State of Kansas. Further, the Board ordered that costs of prosecuting this matter, in the amount of \$23,333.66, be assessed against Licensee as provided by K.S.A. 65-2846.
2. On or about March 17, 2014, Licensee remitted full payment in the amount of \$23,333.66 to the Kansas State Board of Healing Arts.
3. Licensee has satisfactorily met all costs requirements of the Final Order.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from the costs requirements of the Final Order filed on February 3, 2004.

**IT IS SO ORDERED.**


