FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 11th day of February 2006, comes on for conference hearing before the Kansas State Board of Healing (“Board”) the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Ratchnee Satornsantikul France, M.D. (“Applicant”). The Applicant did not appear. Charlene K. Abbott, Licensing Administrator, presented information to the Board.

After reviewing the file, hearing the presentation made by Ms. Abbott, and being duly advised in the premises, the Board finds, concludes and orders as follows:

1. On October 24, 2005, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. As part of the Application, Applicant provided evidence that she received her medical degree from Saba University, Netherlands, Antilles in 2002.
3. Saba University is not an accredited medical school.
4. Saba University first started instruction in 1993 and, therefore, has not been in operation for more than 15 years.
5. Pursuant to K.S.A. 65-2873, to be eligible for licensure by examination, an Applicant must either present proof that the applicant is a graduate of a healing arts school or college or, under subsection (c), that the school has been in operation for not less than 15 years.

6. Applicant has been licensed to practice medicine and surgery in the states of Utah, Washington, and New Mexico.


7. While Applicant does not meet the requirements of K.S.A. 65-2873, Applicant does meet the requirements of K.S.A. 65-2833 and is entitled to endorsement based on her license in three other states.

IT IS THEREFORE ORDERED that the Applicant is eligible for endorsement and her Application for Licensure should be granted at such time as it has been determined to be complete and has been presented to the Board for final approval.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


