FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 11th day of February 2006, comes on for conference hearing before the Kansas State Board of Healing (“Board”) the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Aleksandr Grantovich Gazarov, M.D. (“Applicant”). The Applicant appears in person *pro se*. Charlene K. Abbott, Licensing Administrator, presented information to the Board.

After reviewing the file, hearing the statements of the Applicant and the presentation made by Ms. Abbott, and being duly advised in the premises, the Board finds, concludes and orders as follows:

1. On November 2, 2005, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. This matter was originally scheduled for conference hearing on December 10, 2005, but continued to this date for Applicant to obtain residency evaluations from the residency programs he completed at Texas Tech University.
3. Applicant has provided the residency evaluations as previously requested by the Board.
4. As part of the Application, Applicant provided information that he graduated from Azerbaijan Medical University, Baku, Azerbaijan Republic. This

information included notarized copies of his official transcript and original diploma issued to him by Azerbaijan Medical University.

5. Applicant has been unable to provide a certified statement of professional education as required in part III of the Application and K.A.R. 100-8-2(e) and has requested that the Board waive this requirement.

6. Applicant has provided further information that he is a refugee from the Azerbaijan Republic and to contact Azerbaijan Medical University could be potentially dangerous to him and his family remaining in the Azerbaijan Republic.

7. Applicant has been fully licensed to practice medicine and surgery by the state of New Mexico and has had permits to practice in the states of Texas and Missouri.


8. For good cause shown, Applicant's request for waiver of the requirement that he provide a certified statement from his professional school should be waived.

IT IS THEREFORE ORDERED that Applicant's request for waiver of the requirement that he provide a certification from his professional school is granted.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


