**FINAL ORDER**

NOW, on this 21st day of April, 2007, comes on for before the Kansas State Board of Healing Arts (“Board”) the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Brydon J.B. Grant, M.D.(“Applicant”). Charlene K. Abbott, Licensing Administrator, presents information to the Board. There are no other appearances.

After reviewing the file, hearing the information provided by Ms. Abbott, and being otherwise duly advised in the premises, the Board makes the following findings and orders.

1. On or about December 4, 2006, Applicant filed an Application for Licensure to practice medicine and surgery in the state of Kansas.
2. As part of his application, Applicant provided proof that he graduated from the Charity Cross Hospital Medical School, London, England in May 1968.
3. As part of his application, Applicant provided information he had completed postgraduate training in London England from March 1970 through June 1974 and had participated in a research fellowship at the University of California, San Diego from July 1977 through October 1979.

4. Applicant has also provided information that he has previously held licenses to practice medicine and surgery in the states of Colorado and Michigan and he currently holds active licenses in the states of Utah and New York.

5. Charity Cross Hospital Medical School is not an approved school under K.S.A. 65-2874.

6. Applicant meets all of the requirements for licensure under K.S.A. 65-2873 with the exception of subsection (c)(1) which requires an applicant from an unapproved school to have completed three years of postgraduate training as approved by the Board. Pursuant to K.A.R. 100-6-2, applicants from unapproved schools must have completed at least two years postgraduate training in a program approved by the Council of Education of the American Medical Association or its equivalent.

7. K.S.A. 65-2833 provides discretion to the Board to issue a license to an applicant who has been in the active practice in another state upon certificate from the licensing authority of that state certifying that the applicant license has never been limited, suspended, or revoked and that the licensee has never been censured or had other disciplinary action taken.

8. Applicant meets all of the five requirements of K.S.A. 65-2833 to receive a license by endorsement based upon the certifications of his licenses provided by the states of Utah and New York.

9. Applicant's Application for Licensure, if otherwise complete should be placed on the list for approval at the next regular meeting of the Board.


**IT IS THEREFORE ORDERED** that Applicant is eligible for license by endorsement under the provisions of K.S.A. 65-2833 and his Application for Licensure

should be granted at such time as the Application is determined to be complete and is thereafter presented to the Board for final action at the next regular meeting following that determination.

**PLEASE TAKE NOTICE** that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


