FINAL ORDER

NOW ON THIS 8th day of October, 2005, this matter comes before the Board upon the request of Applicant Travis Heckes, D.C. to terminate the requirements of the August 30, 2004 Final Order. Applicant appears in person. Kelli J. Stevens, Litigation Counsel, appears for the Board.

Having the agency record before it, the Board finds, concludes and orders as follows:

1. The Board issued a Final Order dated August 30, 2004 granting Applicant a license to practice chiropractic. **(Confidential)**

The order also required Applicant's professional practice to be monitored for a period of at least two years by Mark S. Balderson, D.C. These requirements have not been modified since the order was issued.

2. The Board finds that Applicant has not satisfactorily fulfilled the requirements of the August 30, 2004 Final Order. Specifically, Dr. Balderson no longer monitors Applicant's professional practice. **(Confidential)**

4. The Board does not find that further monitoring of Applicant's professional practice is necessary.

IT IS, THEREFORE, ORDERED that Applicant's request to terminate the requirements of the August 30, 2004 Final Order is denied in part and granted in part. Applicant shall be monitored **(Confidential)** for a period of at least one year. Monitoring shall be performed by Mark S. Balderson, D.C., **(Confidential)**


(Confidential) Applicant may request termination of this order after one year following the effective date of this order.

IT IS FURTHER ORDERED that the requirement for monitoring of Applicant's professional practice is terminated.

PLEASE TAKE FURTHER NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon the Board's Executive Director at 235 SW. Topeka Blvd., Topeka, KS 66603.
