**FINAL ORDER GRANTING RECONSIDERATION AND  
ACCEPTING WITHDRAWAL OF APPLICATION**

**NOW** on this 21<sup>st</sup> day of March, 2014, comes before the Kansas State Board of Healing Arts ("Board") the request of reconsideration of the Final Order Denying Licensure filed by Nurul Hoque, M.D. ("Applicant"). Kathleen Selzler Lippert, Executive Director, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-529(b), and upon due consideration of the agency record and applicable law, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about January 14, 2014, Applicant submitted an application for a license by endorsement to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on January 15, 2014.
2. Upon consideration of such application at the February 14, 2014 conference hearing, the Board issued a Final Order on February 24, 2014, denying Applicant's application for licensure by endorsement based on a failure to meet initial qualifications for licensure.
3. On or about March 5, 2014, Applicant filed a timely request for reconsideration of the Final Order pursuant to K.S.A. 77-529, which also included a request that he be allowed to withdraw his application.
4. The Board finds that Applicant's request is based on good cause.



5. The Board concludes it is appropriate in the circumstances to vacate the findings, conclusions and Final Order denying licensure and grant Applicant's request for reconsideration and withdrawal of his application.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Applicant's request for reconsideration and withdrawal of his application for licensure by endorsement to practice medicine and surgery in the State of Kansas are hereby **GRANTED**. Applicant remains licensed under his Kansas institutional license.

**IT IS FURTHER ORDERED** that the February 24, 2014 Final Order Denying Licensure by Endorsement is hereby **VACATED** in its entirety.
