**SUMMARY ORDER**

**NOW**, on this 8th day of April 2006, comes on for summary proceedings before the Kansas State Board of Healing (“Board”) the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Leo Lu, M.D. (“Applicant”). Charlene K. Abbott, Licensing Administrator, presented information to the Board.

After reviewing the file, hearing the presentation made by Ms. Abbott, and being duly advised in the premises, the Board finds, concludes and orders as follows:

1. On June 20, 2005, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. As part of the Application, Applicant provided information that he graduated from the Institute of Medicine, Rangoon, Burma (now known as Myanmar). This information included notarized copies of his office transcript and original diploma issued to him by the Institute of Medicine.
3. Due to the current political situation in Myanmar, Applicant has been unable to obtain a certified statement of professional education as required in part III of the Application and K.A.R. 100-8-2(e) and, by letter dated March 15, 2006, has requested that the Board waive this requirement.

4. Applicant has current and active licenses to practice medicine and surgery in the states of Florida, Oklahoma and Connecticut.


5. For good cause shown, Applicant's request for waiver of the requirement that he provide a certified statement from his professional school should be granted.

**IT IS THEREFORE ORDERED** that Applicant's request for waiver of the requirement that he provide a certification from his professional school is granted.

**PLEASE TAKE NOTICE** that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing within 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the Board upon expiration of the time for requesting a hearing. 
