1. On or about December 22, 2014, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Physician Assistant Licensure Act, K.S.A. 65-28a01, *et seq.* The Consent Order required Licensee attend and successfully complete the continuing education course Intensive Course in Medical Record Keeping with Individual Preceptorships, offered by Case Western Reserve University.

2. On or about December 12, 2014, Licensee submitted to the Board documentation evidencing completion of the Intensive Course in Medical Record Keeping with Individual Preceptorships, offered by Case Western Reserve University, which Licensee completed on approximately November 6-7, 2014.

3. On or about October 30, 2015, Licensee submitted to the Board documentation evidencing completion of the Individual Preceptorships, offered by Case Western Reserve

University.

4. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all requirements of the Consent Order filed on December 22, 2014.
