FINAL ORDER TERMINATING PRACTICE MONITORING

NOW on this 14th day of February 2014, comes before the Kansas State Board of Healing Arts ("Board") the request of William Pankey, MD. ("Licensee") for termination of the practice monitoring requirement contained in the Consent Order filed on April 26, 2013. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of medicine and surgery in the State of Kansas, having been issued License No. 04-36170.
2. On or about April 26, 2013, Licensee entered into a Consent Order with the Board due to Licensee's absence from the active practice of medicine and surgery since December 2009.
3. On June 25, 2013, the Board accepted and ratified the Consent Order.

4. Under the terms of the Consent Order, Licensee was required to attend and successfully complete continuing medical education courses recommended by the Center for Personalized Education for Physicians (“CPEP”) and to have 100% of his practice of medicine and surgery monitored for a minimum of six (6) months.

5. On or about September 5, 2013, Licensee submitted to the Board documentation evidencing completion of his required continuing medical education courses that addressed topics recommended by CPEP.

6. From July 16, 2013 through December 5, 2013, practice monitoring reports were submitted to the Board by Licensee’s practice monitor.


7. On or about December 20, 2013, Licensee submitted a request to the Board for termination of the practice monitoring requirement contained in the Consent Order.

8. On January 17, 2014, the Respondent Board filed a Response to Petition for Termination of Practice Monitoring and provided documentary evidence of Licensee’s compliance with the monitoring requirements.

9. Based on the evidence and testimony presented, the Board finds that Licensee has satisfactorily met all requirements of the Consent Order and concludes that termination of the practice monitoring requirement is warranted.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that the practice monitoring imposed by the Consent Order filed on April 26, 2013, is hereby **TERMINATED**.

Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order.
