JOURNAL ENTRY OF SATISFACTION


COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about August 15, 2014, in accordance with K.S.A. 2011 Supp. 77-537 and 77-514, and as authorized by K.S.A. 65-2836, a Summary Order was issued ordering a civil fine against the license of Michael D. Riley, D.C. (“Licensee”).
2. Pursuant to K.S.A. 77-526 and 77-530, the Summary Order became effective as a Final Order on September 8, 2014.
3. On or about September 29, 2014, Licensee remitted full payment of the civil fine in the amount of \$2,000.00 to the Kansas State Board of Healing Arts.
4. Licensee has satisfactorily met all requirements of the Summary Order and has no further obligation for compliance.


