**ORDER DENYING REQUEST FOR RECONSIDERATION**



In accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, specifically, K.S.A. 77-529, and upon due consideration of the agency record and being otherwise duly advised in the premises, the Board makes the following determination upon Applicant's Request for Reconsideration of the Board's Final Order Denying Licensure:

After considering the arguments presented in Applicant's Request for Reconsideration and the agency Associate Litigation Counsel's Response, the Board finds and concludes that Applicant has presented no compelling new evidence or arguments to demonstrate that the Board's findings of fact and conclusions of law in the Final Order Denying Licensure are erroneous or otherwise should be vacated, modified or that the matter be remanded for further conference hearing proceedings.

**IT IS HEREBY ORDERED** that Applicant's request for reconsideration is DENIED.
