JOURNAL ENTRY OF SATISFACTION


COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about April 17, 2015, in accordance with K.S.A. 2011 Supp. 77-537 and 77-514, and as authorized by K.S.A. 65-2836, a Summary Order was issued ordering a civil fine against the license of Everette T. Sitzman, Jr., M.D. (“Licensee”).
2. On or about April 27, 2015, Licensee remitted full payment of the civil fine in the amount of \$500.00 to the Kansas State Board of Healing Arts.
3. Pursuant to K.S.A. 77-526 and 77-530, the Summary Order became effective as a Final Order on May 6, 2015.
