FINAL ORDER TERMINATING LIMITATION

NOW on this 13th day of June, 2014, comes before the Kansas State Board of Healing Arts (“Board”) the request of James Thompson, Jr., LRT (“Licensee”) for termination of the monitoring requirement contained in the limitation placed on his license in the Final Order filed with the Board on May 10, 2011. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to Board by the Kansas Radiologic Technologists Practice Act, K.S.A. 65-7301 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving evidence, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of radiologic technology in the State of Kansas, having been issued License No. 22-03918.
2. On or about May 10, 2011, the Board issued a Final Order (“2011 Final Order”) granting licensure to Licensee with a limitation on such license.
3. The grounds for the limitation in the 2011 Final Order were Licensee’s 2007 conviction of “Operating While Intoxicated” and possession of marijuana; his termination from

employment at a hospital for marijuana use; and his absence from active practice for over three (3) years.

4. Under the terms of the 2011 Final Order, Licensee's license was subject to a limitation which required he engage in forty (40) hours of practice mentoring within the first month of Licensee's practice; complete twelve (12) supplemental hours of continuing education; comply with all terms and conditions **Confidential**

5. The terms of the 2011 Final Order allowed Licensee to petition the Board for modification or termination of the limitation after successful completion of all requirements.

6. On June 6, 2011, Licensee's practice mentor submitted to the Board a letter that Licensee had completed his forty (40) hours of practice mentoring.

7. On November 3, 2011, Licensee submitted to the Board documentation evidencing completion of twelve (12) additional hours of continuing education.



13. On April 14, 2014, Licensee submitted a request to the Board for termination of the monitoring provisions contained in the 2011 Final Order. The Board construes Licensee's request as a petition to terminate the limitation on his radiologic technologist license.

14. The Board finds that Licensee has satisfactorily met all of the limitation's requirements set forth in the 2011 Final Order and concludes that termination of the limitation on Licensee's license is warranted in the circumstances.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that the LIMITATION imposed by the Final Order filed on May 10, 2011, is hereby **TERMINATED** and that Licensee shall have no further obligation for compliance.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service, and service of a Final Order is complete upon mailing. Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
