**JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about December 17, 2014, Trent J. Timson, D.P.M. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Podiatry Act, K.S.A. 65-2001, *et seq.* The Consent Order required Licensee attend and successfully complete the Medical Record Keeping Seminar offered by the Center for Personalized Education for Physicians (“CPEP”). Further, Licensee was required to participate in and successfully complete the Personalized Implementation Program follow-up component of the Medical Record Keeping Seminar offered by CPEP.

2. On or about December 17, 2014, Licensee submitted to the Board documentation evidencing completion of “Medical Record Keeping Seminar” presented by CPEP on approximately December 5, 2014.

3. On or about January 19, 2016, the Board received documentation evidencing

completion of “Personalized Implementation Program” presented by CPEP on approximately July 30, 2015.

4. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on December 17, 2014.

**IT IS FURTHER ORDERED** that the probation on Licensee’s license to practice chiropractic in the State of Kansas is hereby terminated.
