**FINAL ORDER TERMINATING SUSPENSION OF LICENSE**

NOW on this 28<sup>th</sup> day of August, 2014, comes before the Kansas State Board of Healing Arts ("Board") by and through its Executive Director, Kathleen Selzler Lippert, the request of Jaelyn R. West, A.T. ("Licensee") received by the Board on June 23, 2014, to "reinstate" her suspended license. The suspension of Licensee's license was imposed by a Summary Order which became effective as a Final Order on February 3, 2014. The basis for the suspension was the unprofessional conduct of failing to pay costs in the amount of \$374.80 which were assessed to Licensee by Final Order in KSBHA Docket No. 13-HA00086. Licensee's license was indefinitely suspended until full payment of the costs.

Licensee requests "reinstatement" of her license because the costs Licensee owed to the Board in the amount of \$374.80 were discharged in bankruptcy after her license was suspended. As such, the costs are no longer due and owing.

**IT IS THEREFORE ORDERED** that the **SUSPENSION** of Licensee's license is hereby **TERMINATED**.
