FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 8th day of December, 2007, comes on for before the Kansas State Board of Healing Arts (“Board”) the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Jahan Q. Zeb, M.D. (“Applicant”). Applicant appears by telephone in person *pro se*. Katy Lenahan, Licensing Administrator, presents information to the Board. There are no other appearances.

After reviewing the file, hearing the testimony of Applicant, hearing the information provided by Ms. Lenahan, and being otherwise duly advised in the premises, the Board makes the following findings and orders.

1. On or about May 16, 2007, Applicant filed an Application for Licensure to practice medicine and surgery in the state of Kansas.
2. As part of his application, Applicant provided proof that he graduated from Universidad Technologica De Santiago (“UTESA”), Santo Domingo, Dominican Republic, in August 1997.
3. UTESA is not an accredited healing arts school or college and on August 14, 1999, the Board voted to disapprove UTESA.

4. As part of his application, Applicant provided information he has successfully one-year internships in Neurology and Internal Medicine, a two-year residency in Internal Medicine, a three-year fellowship in Cardiology, and a one-year fellowship in Interventional Cardiology.

5. Applicant has also provided information that he was licensed in the state of Pennsylvania in 2003 and in the state of Oklahoma in 2006, currently holds an active license in both states, and has continuously practiced under those licenses since they were granted.

6. K.S.A. 65-2833 provides discretion to the Board to issue a license to an applicant who has been in the active practice in another state upon certificate from the licensing authority of that state certifying that the applicant license has never been limited, suspended, or revoked and that the licensee has never been censured or had other disciplinary action taken.

7. Applicant meets all of the five requirements of K.S.A. 65-2833 to receive a license by endorsement based upon the certification of his licenses provided by the states of Pennsylvania and Oklahoma.

8. Applicant is eligible for licensure by endorsement pursuant to K.S.A. 65-2833 and Applicant's Application for Licensure should be granted.


IT IS THEREFORE ORDERED that Applicant is eligible for license by endorsement under the provisions of K.S.A. 65-2833 and his Application for Licensure should be granted at such time as the Application is determined to be complete.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order

by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


