General Counsel:

General Counsel Report

Abandoned medical records of Krishna Rajanna, M.D. - The Board is proceeding to obtain temporary custody of Dr. Rajana's medical records and the Dr. has been sent an agreed order to sign. We have 1,200 individual records at present.

Ms. Stevens provided an update of appellate cases involving that Board that had been or are now pending.

Ultrasonic Cavitation (with Medical Director)

Ms. Stevens and Dr. McMaster discussed the procedure and what it involves. Ultrasound is primarily used for diagnostic purposes. What we are looking at now is its use as a therapeutic modality, which is approved in certain areas of physical therapy, chiropractic and the practice of medicine and surgery. The manner in which it is being used as a weight loss (cosmetic) treatment appears to be the practice of medicine and surgery. It can be performed in a legitimate medical practice. The Board has information that it is also being performed in businesses that are not medical practices. It appears to be performed by non-licensed individuals who do not have medical oversight. Dr. McMaster will be looking into this further.

Disapproved Schools

Ms. Stevens presented information indicating that the medical schools could be disapproved based on the following regulatory grounds:

- **1.** Universidad CETEC, Santo Domingo, Dominican Republic (closed 1984) disapprove for all graduates based on insufficient information concerning the program. K.A.R. 100-6-3(b)(2)
- **2.** Universidad CIFAS Escuela de Medicina, Santo Domingo, Dominican Republic (closed 1984) disapprove for all graduates based on insufficient information concerning the program. K.A.R. 100-6-3(b)(2)
- **3.** Spartan Health Sciences University School of Medicine, Vieux Fort, Saint Lucia disapprove for all graduates based on failure to require an undergraduate degree and lack of an entrance examination. Failure to have adequate admission requirements of K.A.R. 100-6-3(b)13)
- **4.** University of Health Sciences Antigua School of Medicine, St. John's, Antigua and Barbuda (open)- disapprove for all graduates based on lack of an entrance examination/failure to have adequate admission requirements K.A.R. 100-6-3(b)13)
- **5.** Universidad Federico Henriquez y Carvajal, Santo Domingo, Dominican Republic (closed 1998)- disapprove for all graduates based on insufficient information concerning the program. K.A.R. 100-6-3(b)(2)
- **6.** Kigezi International School of Medicine, Cambridge, England (closed) and Kabale, Uganda (closed)- disapprove for all graduates based on the school not being located in a college that is legally recognized and authorized by the jurisdiction in which it is located to confer the M.D. or D.O. degree. K.A.R. 100-6-3(b)(4)

(Conley/Beezley) Disapprove medical schools on the basis of not meeting the regulations as set forth by the General Counsel. Carried.

Litigation Counsel:

Litigation Report

The statistical report for the Litigation department was distributed and reviewed: 176 open cases at present, 75 new disciplinary cases received in the last two months, 31 closed cases since last board meeting. Since last April they closed 252 cases with 200-250 being the normal rate of closure for a 12-month period. There are 4 formal hearings currently pending.

Disciplinary Counsel:

Disciplinary Report

The statistical report for the Disciplinary department was distributed and reviewed. Numbers for last period had spiked but they were more normal for this period (time period since last board meeting). Number of investigations on the "greater than 2 years" list has dropped by almost 7%. There were 92 cases closed between December and February board meetings and 104 cases closed between February and April board meetings. The total number of investigations has gone up by 15 since last time period, making for full agenda's for review committees. This, in turn, will likely increase the agenda for the disciplinary panel and the case load for Litigation staff.

Executive Director:
