- I. Call to Order:** Meeting called to order by Dave Sanderson at 2:03

- II. Approval of Minutes from August 12, 2015:** Approved (Baird – Martin)
- III. New Business:**
- A. FSBPT Meeting Report -** Mr. Martin reported back from the meeting. He stated that overall there was very little new information on dry needling. Mr. Martin stated that CAPTE is considering adding dry needling as required course work for PT programs, possibly as soon as 2018. The meeting also had discussions on a licensure compact between states. Ten states will be required to start the compact and potential statutory language has been drafted.
  - B. FSBPT Star Rating –** Mr. Martin reported that Kansas dropped from 3 stars to a 1 star in the FSBPT rankings. Low ratings could cause Kansas exclusion from consideration for the licensure compact. Ms. Stevens will look at the criteria for increasing the scores and report at the next meeting.

- A. Proposed changes to K.A.R. 100-29-9:** Ms. Stevens reported that the draft is now at the Attorney General’s office for review.
  - B. Proposed changes to K.S.A. 65-2914 and K.A.R. 100-29-16:** Ms. Stevens stated that once K.A.R. 100-29-9 is reviewed both K.A.R. 100-29-9 and K.A.R. 100-29-16 will be added to changes with the OT regulations for publication. Once published, there will be a 60 day public comment period.
  - C. Dry Needling:** Ms. Stevens reported that at the October, 2015 Board meeting KPTA’s memo was reviewed and discussed. The Board agreed to a general request to KPTA to sponsor legislature change. Once the minutes from the October Board meeting are approved, Ms. Stevens will forward the minutes to the Council members.
