II. Approval of Minutes from November 12, 2014: approved (Baird-Martin)

III. New Business:

A. Discussion from the AT Council, is it appropriate for a PT to be able to provide aid on the field and return to play care? Mr. Baird and Mr. Martin stated that ATs are trained in on-field treatment (e.g. concussion management) and that type of training would not be under physical therapy. They both believe that return to play is appropriate for either. Mr. Sanderson said that PTs are not trained in environmental medicine; therefore, he believes there are many differences between the professions. It was agreed that it is best to provide care within each profession's scope of practice.

IV. Old Business:

- A. Proposed changes to K.A.R. 100-29-9: Ms. Stevens provided a handout with the revisions. Ms. Stevens stated that she added criteria for residencies and fellowships as determined by the American Board of Physical Therapy Residency and Fellowship Education or sustainably equivalent. Following a discussion, it was determined that more information is needed. Mr Sanderson was nominated as the designee to review the final language revisions (Baird Martin).
- **B. Proposed changes to K.S.A. 65-2914 and K.A.R. 100-29-16:**Ms. Stevens provided a handout with the revisions. The revisions should be approved and move on to the hearing process.
- **C. Dry Needling:** Ms. Lippert stated that the issue was discussed at the December 2014 Board meeting and is still pending.
