- II. Approval of Minutes from February 11, 2015:** approved (Gould – Baird)
- III. New Business:**
- A. 2015 FSBPT Annual Meeting Nomination for Delegate:** Mr. Martin volunteered as voting delegate and Mr. Sanderson may go as alternate delegate. Mr. Sanderson will let Ms. Lenahan know prior to the June 30, 2015 registration deadline. Ms. Lenahan will complete the registration.
 - B. Pro-Cert:** Ms. Lenahan presented an e-mail from Julie Newman with 3 options for Pro-Cert: 1) these courses are not tracked 2) conversion formula or 3) competency hours equals CE hours. Mr. Martin motioned that the licensee should provide the instructional time frame of the course and be awarded continuing education hours based on the instructional hours. (Martin-Baird). Passed. - A. Proposed changes to K.A.R. 100-29-9:** Ms. Stevens stated that the revision was returned again because of referencing the publication from the American Board of Physical Therapy Residency and Fellowship Education. Ms. Stevens suggested requiring 1000 hours in a program to replace the reference. Following a discussion, it was determined that many programs do not require 1000 hours. It was agreed to change it back to 40 hours CEUS for completion of a residency or fellowship.
 - B. Proposed changes to K.S.A. 65-2914 and K.A.R. 100-29-16:** Ms. Stevens stated that this is completed and just waiting on KAR 100-29-9 so they can move through the regulator process together.
 - C. Dry Needling:** Ms. Stevens stated that the topic is on the agenda for the June 12, 2015 Board meeting. She will summarize the PT Council and subcommittees opinions and she will provide legal analyses to the Board members.
