To Whom It May Concern:

This letter is to explain statutory changes to Healing Arts and Physician Assistant Renewal statuses and repeal of "expired" license status for doctors of medicine and surgery (MD), doctors of osteopathic medicine and surgery (DO), doctors of chiropractic medicine (DC), and physician assistants (PA). [see K.S.A. 65-2809 and 65-28a03]

The designated renewal period for each profession remains the same for both the regular and late renewal period. The statutory change has repealed the status of "expired". A licensee's license remains in their designed status during the whole renewal period.

MD Renewal (regular)*	June 1 – 30
MD Renewal (late)	July 1 – 31
MD cancel date	August 1 <sup>st</sup>
DO Renewal (regular)*	Sept. 1 – 30
DO Renewal (late)	Oct. 1 – 31
DO cancel date	November 1 <sup>st</sup>
DC & PA Renewal (regular)*	Dec. 1 – 31
DC & PA Renewal (late)	Jan. 1 – 31
DC & PA cancel date	February 1 <sup>st</sup>

\*Each regular renewal period opens approximately 15 days early.

All renewals during the late renewal cycle will pay a LATE fee in addition to the regular renewal fee.

Failure to renew by the end of the late renewal period will result in a cancelled license for failure to renew. If a license is cancelled for failure to renew, an application for reinstatement will be required to obtain a valid license.

A license status will remain the same during the whole renewal period; a license will NOT have an expired status.
